

# Starting Patients On VUMERITY



You play an important role in starting patients on VUMERITY, and **Biogen Support Services** is here to help.



## Start patients on VUMERITY by completing the Start Form, accessible via:

✓ **E-Sign (DocuSign®)** at [www.VUMERITYhcp.com](http://www.VUMERITYhcp.com)

✓ Paper form faxed to **1-855-474-3067**

✓ **iAssist®** or **CoverMyMeds®**

- Once the Start Form is submitted, **Biogen Support Services** will send the prescription to a specialty pharmacy to complete a Benefits Investigation on your behalf
- Patients must sign Sections A and B in order for a **Biogen Case Manager** to proactively call them
- Completing the Start Form expedites patient enrollment in **Biogen Support Services**

**Remind your patients to expect phone outreach from Biogen Support Services and the specialty pharmacy. Patients should return any missed calls as soon as possible to avoid treatment delays.**



## The specialty pharmacy may contact your office if a PA and/or exception is required, and additional information is needed

- If your office is completing the PA, obtain the proper form, fill it out accurately and completely, and submit it using the health plan's preferred method
- If the PA is approved, the specialty pharmacy will arrange shipment of VUMERITY directly to the patient

**Documentation that may further support a PA request includes: complete clinical notes, MRI and other clinical data related to disease level, and documented failure of another disease-modifying therapy.**



## If a request was denied, review the reason for denial

**If denied for nonclinical reasons**, it should be resubmitted with the required or corrected information

**If denied for clinical reasons**, verify the appeals process with the health plan, complete the appeal fully and accurately, and file it within the health plan's time limits

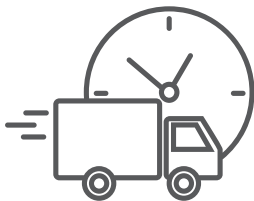
## **Financial and insurance resources offered by Biogen Support Services include:**

- Communicating with insurance companies to clarify and confirm coverage, including assistance with the PA process and denied claims
- Insurance counseling that educates uninsured and underinsured patients on government insurance programs
- Financial assistance options



## **The Biogen Copay Program may lower medication cost to as little as \$0 for eligible patients with commercial insurance\***

- Eligible patients can enroll in the **Biogen Copay Program**, regardless of income
- Once enrolled, eligible patients can stay in the **Biogen Copay Program** as long as they meet the requirements



## **The QuickStart Program provides VUMERITY at no cost to eligible patients while prescription coverage is being secured**

- You may authorize Biogen to provide VUMERITY through the **QuickStart Program** on the Start Form
- **Biogen Support Services** will then assess program eligibility during patient outreach

## **Help Your Patients Get Support**

**Your patients can call 1-800-456-2255 Monday-Friday from 8:30 AM to 8 PM ET**

\*There is an annual cap on the amount of assistance that patients can receive over a 1-year period. Federal and state laws and other factors may prevent or otherwise restrict eligibility. People covered by Medicare, Medicaid, the US Veterans Administration/Department of Defense, or any other federal plans are not eligible to enroll. Patients are eligible to enroll in the Biogen Copay Program for as long as it is offered and they are treated with VUMERITY.
